

Sub: Constitution of Single Judge Benches

Hon'ble Sir,



The Supreme Court Bar Association is shocked to note that amendment to Order VI Rule 1 of the Supreme Court Rules 2013, has been brought whereby the constitution of Single Judge Benches has been provided for.

The matter has been considered by the Executive Committee of the Supreme Bar Association today i.e. 20.09.2019 and the following resolution has been passed:

#### RESOLUTION

"The Executive Committee of the Supreme Court Bar Association has noted with utmost shock and surprise and expresses its strong dissent and opposition to the amendment brought in Order VI Rule 1 of the Supreme Court Rules 2013, whereby provisions have been made for hearing and disposal of the matters finally by a Judge sitting singly nominated by Hon'ble the Chief Justice for disposal of the Special Leave Petitions arising out of grant, dismissal or rejection of Bail Application or Anticipatory Bail Application in the matters filed against the order passed under section 437, section 438 or section 439 of the Code of Criminal Procedure, 1973 involving the offences punishable with sentence up to seven years imprisonment; Applications for transfer of cases under section 406 of the Code of Criminal Procedure, 1973; Application of an urgent nature for transfer of cases under section 25 of the Code of Civil Procedure 1908 and any other category of cases notified by the Chief Justice from time to time.
